HIGHLIGHTS

BRUNCH BILL – In October, Cashiers Area Chamber executive director Stephanie Edwards spoke before the Jackson County Commission re: passage of the opt-in ordinance to allow for Sunday 10:00 am alcohol sales. The board did not take action on the item and instead agreed to hold a public hearing. The Chamber has formally requested that a hearing be held in the spring in the Cashiers Area so that stakeholders will have a more convenient opportunity to provide valuable input. A recent Crossroads Chronicle poll showed 84% of respondents in favor of the measure.



DESTINATION SIGNAGE – A second Cashiers destination sign was installed on NC 107 South north of the High Hampton Inn entrance (shown). A Glenville/Cashiers dual sign is in production and will soon be installed at the intersection of NC 107 North and Laurel Knob Road. High Hampton Inn and Mountaintop Golf & Lake Club generously donated the sites and the Cashiers Area Chamber has funded these through generous corporate and community contributions. Until the fourth remaining permanent Cashiers sign, on US 64 East, is in place, a temporary billboard has been erected. Note: The JCTDA provided \$2,500 in grant monies toward the construction of the inaugural sign. Total cost for the project will be in excess of \$15,000. **PEDESTRIAN MOBILITY & SAFETY** – Expansion and marker upgrades were announced for community pathways system around the Cashiers Crossroads. TDA board members Ann Self and Stephanie Edwards serve on the volunteer committee to promote The Village Ramble, which is prominently featured in The Village Green central park. Edwards also recently updated the Cashiers Planning Council on the Chamber's efforts to promote pedestrian mobility through public works funding and awareness campaign.

VISITOR CENTER FACILITY IMPROVEMENTS – Balsam West fiber installation is in progress and training and final set will occur week of 11/21. Major chimney repair complete and bids out for additional wood replacement, exterior cleaning and painting. Received \$1,625 donation from the Valley Garden Club to improve visitor center landscaping. Utility pole removed from front bed to promote visibility.
