## Dear Jackson County Tourism Development Authority Board Members:

As current/former JCTDA Board Members, Committee Members, Cashiers Area Chamber Officers and Directors and other stakeholders, we ask for your favorable consideration of the JCTDA grant application submitted by the Cashiers Area Chamber of Commerce to conduct a ULI Americas Advisory Services Panel in Cashiers, NC. We emphasize that this project <u>has</u> <u>widespread community support</u> as it brings <u>national resources</u> -- typically available only to towns, cities and large entities which can rely on major government or corporate funding -- to Western North Carolina.

Jackson County and specifically unincorporated Cashiers, have a timely and unique opportunity to be the subject of an Urban Land Institute (ULI) Americas Advisory Services Panel. This process brings together the best and brightest professional planners, market analysts, economists, architects, natural and built environmental specialists, land developers, public officials and more to offer practical solutions and objective growth management advice not available from any other source. The Chamber will serve as the project Sponsor, responsible as the contracted agency, and will manage administration and logistics.

## We ask you to support this inclusive, transparent, unbiased and expert process to analyze critical Cashiers Area growth issues which are paramount to tourism industry success in our destination and our county at large.

These economic development issues include preservation of community character and heritage, local services including hospitality, accommodations, workforce housing, pedestrian mobility and safety, transportation management, infrastructure expansion, environmental conservation and scenic quality, public amenities and more.

We urge your approval of the Chamber's \$35,000 JCTDA grant request toward the \$135,000 total cost of the panel. More than \$50,000 has been raised from the community to date with additional commitments made and requests pending.
