Describe the timing of the initiative in as much detail as	We would like to sign a contract for the Pinnacle Park Master Plan in March and have it completed by December. The survey portion (required

for PARTF grant) would be completed by May. All site analysis would be

completed by July. Preliminary designs would follow and be accompanied

with public forums that would wrap up by the end of September. The final plan would be complete in November. December would be for working on

the PARTF grant application as well as other grant applications.

Describe your initiative

Pinnacle Park is at a crossroads. The area of the park itself is nearly doubling to approximately 1800 acres with the addition of several adjacent land parcels. In addition, the Plott Balsams corridor from Water Rock Knob to the Qualla Boundary is undergoing a major makeover as EBCI and several NGO's seek to consolidate this land area for the public good. The park is already a destination for a diverse group of users, including hikers, rock climbers, trail runners, naturalists, and even paragliders. Recreational pressures on the park will only grow as evidenced by a recent proposal to develop mountain biking trail on the property. The Pinnacle Park Foundation, in tandem with the Town of Sylva, believe we need a Master Plan to guide future development that best addresses the needs of the public while protecting the Park's sensitive natural resources. There are already major trail erosion issues that need to be addressed, and these problems will only become more severe. We need a comprehensive survey of the community's wants and we need to balance that with the fragility of the resource we are charged with protecting in perpetuity. We believe a Master Plan will identify the best way to rehabilitate our trail system, increase accessibility to all users, provide adequate infrastructure, and perhaps even identify new trail destinations that are both ecologically sound and follow professional design guidelines.

Describe what previous experience applicant has in successful execution of similar endeavors

This effort would be led by the Pinnacle Park Foundation which has extensive experience in the successful execution of such contracted studies. The Pinnacle Park Foundation board is made up of WCU Professors, a local attorney, community and municipal leaders, as well as numerous experienced community organization leaders. The Pinnacle Park Foundation has just completed a contracted comprehensive botanical survey of Pinnacle Park. This board of volunteers wrote the request for proposals, evaluated and selected a contractor, and oversaw the entire botanical survey contract.

Give a narrative description of how this project will increase tourism and visitation in Jackson County The Pinnacle Park receives visitors from all across the country. A trip to the parking lot on any given weekend will show license plates from nearly a dozen different states. Ecotourism is one of the main drivers of our local economy and the economic impact of one of the largest municipally-owned parks in our state should not be underestimated. It's easy accessibility from The Town of Sylva makes it perfect for a day hike and a quick and easy drive afterwards to one of our many restaurants or breweries to refuel after the grueling hike to Pinnacle Peak. Pinnacle Park's usage rates are climbing and with investments in better infrastructure the park will be suited to support this growth and even accelerate it. But that infrastructure investment needs to be professionally planned and designed to suite the needs of the users who visit the park. This is the information this plan will provide.

If this initiative has occurred before, what is new that differentiates it from prior years? There has never been a comprehensive assessment, maintenance plan, infrastructure study, or analysis of the current users of Pinnacle Park.

What is your advertising and marketing plan for your initiative?

There will be numerous stakeholder meetings as well as public forums for people to provide input. One contractor is also proposing that park branding and website development be included in the plan.
