Describe the timing of the initiative in as much detail as possible (please list key project dates, milestones, timeframes, etc.)

This essential initiative will begin immediately upon funding. Trail counter equipment will be purchased in January 2024 to be installed in February and March in anticipation for busy spring, summer, and fall outdoor recreation seasons.

Trail maintenance and trail improvements will be ongoing throughout 2024 with public trail work days and conservation projects scheduled on the first Tuesday and third Saturday each month, plus additional work days and projects by invitation for groups and individuals.

Resource assessments and management of the project will be ongoing.

Quarterly updates will be provided to JCTDA. We expect to share our visitation data collected from the new trail counters for the quarterly periods of June 30, September 30, and December 31, 2024.

Public kiosk plans will be submitted to the County for approval before construction. A licensed contractor will be hired to perform the work. Depending on when approval is received, we expect to complete construction within 6 months, or as soon as logistically possible.

Describe your initiative

The purpose of the Panthertown Valley Enhancement Project is to support trail maintenance and improvements to the 30 mile public Panthertown Valley Trail System, support Phase 2 of the Panthertown Valley Visitor Data Collection Program, support continued natural resource assessments and monitoring, and support analysis of assessment data and trail counter data, all of which will aid in informing management decisions for Friends of Panthertown and the U.S. Forest Service Nantahala District.

Friends of Panthertown has installed and continues to maintain trail counters throughout the Panthertown Valley Trail System. This initiative will enable us to continue to manage, maintain, and improve this important program, all while aiding in enhancing the visitor experience.

Visitors to Jackson County will also benefit from a public information kiosk located at 116 Central Street in downtown Sylva which will provide maps, Leave No Trace information, and public notices concerning Panthertown and other trail systems in Jackson County.

Describe what previous experience applicant has in successful execution of similar endeavors

Friends of Panthertown staff assess, maintain, and improve more than 30 miles of public trails in Panthertown Valley for the benefit of all who visit, and for the surrounding community and our tourists to have access to the natural resource.

We coordinate contracted trail work plus hundreds of volunteers each year, including in 2022 a total of 254 participants who generously contributed 1,767 hours on the ground, over 54 work days, with a combined in-kind value of over \$74,000. So far in 2023 we have coordinated and trained 232 volunteers who have contributed 1,616 hours at an in-kind value of \$48,480.

In response to the significant increase in visitation during the pandemic, Friends of Panthertown created a visitor data collection program and received a \$10,000 grant from JCTDA in 2021 to purchase and install 17 strategically placed trail counters in Panthertown.

With over a year of visitation data collected, we now have a much better understanding of Panthertown Valley's trail usage, visitation trends, and conservation needs related to the trail system.

We have worked in partnership with JCTDA for public benefit for many years and we look forward to continuing our partnership.

Through donations and grants, Friends of Panthertown provides funding for resource protection and conservation projects throughout Panthertown. Our organization enables trail construction, maintenance, and recreational improvements along the 30-mile Panthertown Valley Trail System, and within its recreational corridors, and teaches Leave No Trace and Bear Wise education in Panthertown, and in the surrounding community. We provide public stewardship opportunities, trainings, and the coordination of hundreds of volunteers and citizen scientists each year who have contributed thousands of hours to protect the natural resources and improve the recreational opportunities in Panthertown for the benefit of the public. We collaborate with our partners, including the U.S. Forest Service, to conserve Panthertown, engage its stakeholders, and educate the community. We have strong public support and cooperative partnerships that help us to sustain the important conservation work needed in Panthertown.

Give a narrative description of how this project will increase tourism and visitation in Jackson County Visitors to Jackson County will benefit from a public information kiosk to be constructed with grant funds at 116 Central Street in downtown Sylva which will provide maps, Leave No Trace information, volunteer opportunities, event listings, and official public notices concerning Panthertown and other trail systems in Jackson County. This outdoor recreation kiosk will be available 24 hours a day as a public service and amenity.

Maintained and improved trails will benefit all visitors to Panthertown and will increase tourism and visitation as the visitor experience is maintained and improved. Trail experience review websites such as AllTrails, combined with visitor posts on social media, will see an increase in likes, comments, and shares related to Panthertown which will results in an increase in outdoor recreation tourism and visitation in Jackson County. This will in turn lead to increased investment in our community, and in particular economic enhancement for local lodging, retailers, restaurants, and other hospitality businesses.

Visitors will experience immediate benefits from trail improvements. Families, students, outdoor enthusiasts, and various user groups such as hikers, mountain bikers, equestrians, kayakers, rock climbers, birders, anglers, and backpackers will all enjoy the advantages of well-maintained backcountry trails and trailheads. These individuals rely on the public trails in Panthertown Valley to engage in recreational activities, improve their physical health, enhance their vitality, and nurture their mental well-being. By providing a positive and inclusive outdoor experience, our goal is to inspire these visitors to continue to return to Jackson County while engaging with their public lands as good stewards and responsible recreation users.

If this initiative has occurred before, what is new that differentiates it from prior years? After receiving funding in 2021 for \$10,000 to go towards Phase 1 of our trail counter program, we began purchased the system and installing the counters in Panthertown. With more than one year of visitation data in hand, and after managing and maintaining the trail counter system, we are able to see where additional counters are needed, the amount of time and resources required to manage the program, and how we can improve this program significantly with the addition of strategically placed counters purchased and installed.

What is your advertising and marketing plan for your initiative?

We will utilize our website, email list, social media channels, public events, and traditional media to reach the community and herald the initiative. Press releases in the local newspapers, radio stations, and social media groups will enable us to reach a wide audience. An announcement of the grant will be sent out in January and regular updates will occur throughout the initiative. Once a public kiosk is built this will become an additional channel to market the initiative.

How did you determine audience/attendance numbers and where do they come from?

We anticipate an estimated 65,000 annual visitors and 250 or more volunteers to work with us in 2024, based on past years' data, and we use trail counter data, U.S. Forest Service data, Stava Metro data, AllTrails data, and visual counts to determine the visitation in Panthertown.

Based on visual observation of vehicle license plates in the parking lots on busy weekends, entrance and exit surveys, and qualitative data generated by visitor comments, we anticipate more than 65,000 visitors to Panthertown Valley in 2024, with more visitors expected from outside of Jackson County than from within.

How will you measure success of your initiative?

We will measure the success of the Panthertown Valley Enhancement Project by surveying our visitors, monitoring public comments about their visitor experience, keeping track of visitation data, assessing and analyzing natural resource data, recording the dates and number of scheduled work days coordinated by our staff, the number of participants that attend each word day the number of volunteers trained to participate in the work, and the number of hours dedicated by our staff to coordinate the project and associated work.

After each work day we will survey our participants to find out what they learned, how we can improve our program, and if they would like to return again to work with Friends of Panthertown on these and other conservation and stewardship projects in Panthertown.

We will recognize and provide regular reports of these measurements to JCTDA during the grant period and beyond, as a partner in this initiative, along with the U.S. Forest Service and Friends of Panthertown.




